- Identifiable of the incident; reflective of the community's resiliency

#### ADVANTAGES/DISADVANTAGES OF EACH POSSIBLE SITE

#### 1. Rose Garden; east/north of Rose Garden

#### **Positive**

- Opt-in
- Owned by city/PDHP
- Close to transportation
- Already established
- Positive feedback, particularly by victims

#### Concerns/considerations

- Limited on-site parking
- Consider options for temp memorial during construction
- Rose garden landmarked

- Private
- Close to city hall/appearance of security
- Proximity to shade, restrooms
- Electricity/water/infrastructure established
- Meets DOJ trauma informed site

## 2. Port Clinton Plaza

Consider this site as a small marker; complimenting the Place of Remembrance

#### <u>Positive</u>

- Owned by City
- Close to transportation
- Proximity to shade, restrooms
- Electricity/water/infrastructure established
- Open gathering area
- Accessible
- Family friendly/restaurants

#### 3. SWC St. Johns & Central

#### <u>Positive</u>

- Owned by City
- Close to transportation
- Proximity to shade, restrooms
- Electricity/water/infrastructure established
- Accessible
- Family friendly/restaurants

# Concerns/considerations

- Potential retraumatization regardless of the remembrance
- Virtually unavoidable
- Will define City's business district
- Very impactful to adjacent businesses
- Coordination with Port Clinton Associates
- Direct eye site to shooting location
- Impactful to children
- Contrary to downtown vibrancy and goal of silence, reflection, solace
- Limited space

# Concerns/considerations

- Too small
- Potential retraumatization regardless of the remembrance
- Virtually unavoidable
- Will define City by the tragedy, including commuters
- Very impactful to adjacent businesses
- Impactful to children; on school bus route by running and cycling route
- Contrary to downtown vibrancy and goal of silence, reflection, solace
- Too close to train
- Busy street corner

## Concerns/considerations

- Site being considered for alternate use, PDHP in partnership with HP Hospital
- Limited access to electricity/water/infrastructure
- Limited access to transit
- Currently limited access for people with disabilities
- Insufficient parking

# 4. Sunset Park (north side), ~1 acre <u>Positive</u>

- Owned by PDHP
- Proximity to shade, restrooms
- Accessible
- Well known to the community

- Proximity to hospital/sirens
- Impactful to children

#### 5. Ross property

#### <u>Positive</u>

- Close to transportation
- Proximity to shade, restrooms
- Electricity/water/infrastructure established
- Accessible
- Family friendly/restaurants

# 6. Central between First and Second Positive

- Owned by City
- Close to transportation
- Electricity/water/infrastructure established
- Accessible
- Family friendly/restaurants
- Reflective of positive memories of July 4<sup>th</sup> parades along Central

## Concerns/considerations

- Shooting location
- Privately owned
- Cost consideration
- Potential retraumatization regardless of the remembrance
- Virtually unavoidable
- Will define City's business district
- Very impactful to adjacent businesses
- Impactful to children
- Contrary to downtown vibrancy and goal of silence, reflection, solace

#### Concerns/considerations

- Too impactful to downtown businesses and residents
- Traffic management from a safety perspective
- Potential retraumatization regardless of the remembrance
- Virtually unavoidable
- Will define City by the tragedy, including commuters
- Very impactful to adjacent businesses
- Impactful to children; on school bus route by running and cycling route
- Contrary to downtown vibrancy and goal of silence, reflection, solace
- Too close to train

Other sites discussed but removed from consideration include other parks such as Brown Park, Olson Park.
